4. TERMS OF CONTRACT

- a) Selected candidates shall be appointed on purely contractual basis for the maximum period of one year or till the joining of regular faculty whichever is earlier.
b) The Contractual engagement may be terminated / discontinued on either side giving one-month prior notice to this effect without assigning any reason.
c) Other terms and condition will be applicable as issued by competent authority from time to time.
d) This being 01 Year contract, absence for period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and security deposit will be forfeited.

Please bring all relevant Original certificates and their self-attested photocopies (1 sets), 2 copies of passport size photographs and the relevant certificates issued by the competent authority in the form prescribed by Government of India, Department of Personnel & Training for consideration of reservation to the reserved candidates. Failing which they will not be allowed for interview.

6. SELECTION PROCEDURE:

- a. Selection will be made on basis of interview of candidates which will be conducted by selection board.
- b. All eligible candidates should apply in the application format available at the registration counter on 02.07.2019
- c. Selected candidates will have to join immediately after receipt of offer of Appointment.
- d. The final selection will be based purely on performance in the personal interview.**

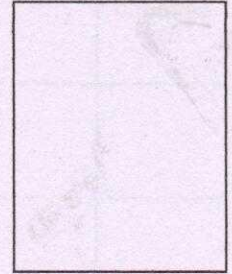
